To date, IMA has distributed more than \$1 billion worth of critical supplies worldwide.

PROJECT APPROACH

Gifts in Kind (GIK) and Procurement

Since 1960, IMA has received donations of essential medicines and medical supplies from US and European manufacturers and hospitals to support overseas health care programs.

IMA upholds the highest standards for responsible giving of in-kind donations, carefully monitoring the expiration dating and quality of the donation. We respond to the needs of local health care professionals and provide only what is appropriate for the health needs in the recipient country. We adhere to the donation guidelines established by the World Health Organization for international giving, and IMA offers these donated products at significantly reduced prices to our Member agencies, approved partners, and volunteer medical mission groups. Products from IMA's gifts-in-kind program have been sent to more than 72 countries around the world.

Also, IMA's country programs, currently operating in Africa, Asia, and Haiti, utilize a health systems strengthening approach that includes procurement of essential pharmaceuticals and supplies for project catchment areas. IMA is licensed for pharmaceutical procurement by the US Drug Enforcement Administration and the State of Maryland. Due to our longstanding partnerships and procurement volume, we are able to purchase medicines and medical products at discounted rates in the US, globally, or in the recipient country.
